The NLRA is a <u>federal law</u> that grants employees the right to form or join unions; engage in protected, concerted activities to address or improve working conditions; or refrain from engaging in these activities. The NLRB is an independent federal agency created to enforce the National Labor Relations Act. Headquartered in Washington DC, it has <u>regional offices</u> across the country where employees, employers and unions can file charges alleging illegal behavior, or file petitions seeking an election regarding union representation. The NLRA applies to most private sector employers, including manufacturers, retailers, private universities, and health care facilities. The NLRA does <i>not</i> apply to federal, state, or local governments; employers who employ only agricultural workers; and employers subject to the Railway Labor Act (interstate railroads and airlines).
