The NLRA is a <u>federal law</u> that grants employees the right to form or join unions; engage in protected, concerted activities to address or improve working conditions; or refrain from engaging in these activities. The NLRB is an independent federal agency created to enforce the National Labor Relations Act. Headquartered in Washington DC, it has <u>regional offices</u> across the country where employees, employers and unions can file charges alleging illegal behavior, or file petitions seeking an election regarding union representation.
